### Florida Higher Education Coordinating Council Members

*The 2013 Florida Statutes, Chapter 1004.015*

*History.—s. 13, ch. 2010-78; s. 5, ch. 2011-177; s. 7, ch. 2012-195; s. 8, ch. 2013-51.*

The council serves as an advisory board to the Legislature, the State Board of Education, and the Board of Governors.

Appointed members shall serve 2-year terms, and a single chair shall be elected annually by a majority of the members.

The council will submit an annual report and its recommendations by December 31.

1. One member of the Board of Governors, appointed by the chair of the Board of Governors.
2. The Chancellor of the State University System.
3. The Chancellor of the Florida College System.
4. One member of the State Board of Education, appointed by the chair of the State Board of Education.
5. The Executive Director of the Florida Association of Postsecondary Schools and Colleges.
6. The president of the Independent Colleges and Universities of Florida.
7. The president of Workforce Florida, Inc., or his or her designee.
8. The president of Enterprise Florida, Inc., or a designated member of the Stakeholders Council appointed by the president.

Three representatives of the business community, who are committed to developing and enhancing world class workforce infrastructure necessary for Florida's citizens to compete and prosper in the ever-changing economy of the 21st century.

9. One appointed by the President of the Senate.
10. One appointed by the Speaker of the House of Representatives.
11. One appointed by the Governor.
